In 1763, Britain defeated France in a war which both countries wanted control of trade with Native Americans living in the Ohio River Valley. The colonies supported Britain. They were hoping that control by the British of that region would allow them to expand westward. This war was known as the French and Indian War. The war got its name as both sides had been aided by the Indians in fighting. The Treaty of Paris, a peace treaty that formally ended the war, gave Britain control of Canada and most of the land east of the Mississippi River.

Britain needed money to pay for the war. The war cost the British a good deal of money. Britain also felt they needed to keep soldiers in the region to protect their new lands. This added to their expenses and a continued strain of the budget. The people of Britain did not feel they should pay extra taxes to support distant colonies across the ocean.

3. How did the British people feel about paying extra taxes?

In 1765, King George and Parliament decided to **impose** new taxes on the colonists. One of the first new taxes was the Stamp Act of 1765. This was a tax on anything that was written or printed in the colonies. The colonists felt that their local representatives should pass tax laws for the colonies. Colonists felt that there should be, "No taxation without representation!" Soon other taxes such as the Townshend Acts were placed on the colonies. These were extra taxes on items such as paint, glass, and tea. The colonists **protested** and **boycotted** goods imported from Britain. Britain did **repeal** most of the new taxes but continued to enforce the tax on tea. This made the colonists very mad.

Britain continued to enforce the tax on tea. This was called the Tea Act. This tax was a way to show the colonists that the British government was still in control. The Tea Act allowed the British to sell tea to the colonies more cheaply than the local colonial tea traders. This hurt those colonial merchants **financially**. Samuel Adams and Patrick Henry, both members of the Sons of Liberty, spoke out to the colonists against what the British were doing.

Feelings between the British and colonies grew worse. Many colonists were angry at the British government. On March 5, 1770, five colonists were killed as they yelled and threw snowballs at British soldiers. This became known as the Boston Massacre. On December 16, 1773, fifty members of the Sons of Liberty, led by Samuel Adams, boarded three ships in the Boston Harbor. They disguised themselves as Native Americans. Once aboard the ships, they proceeded to dump 15,000 pounds of tea into the Boston Harbor. This was called the Boston Tea Party.

King George was angry at the **destruction** of British property. He had the British Parliament to impose upon the colonists the Intolerable Acts. Under the Intolerable Acts, the Boston Harbor was shut down to the colonists. Colonists were also made to house British soldiers in their homes if needed. British General Thomas Gage was made the new governor of Massachusetts. The king wanted to **punish** the colonists with the Intolerable Acts. This act by the king only made the colonists more united as a group.
